

PROCEDURE FOR RELEASE OF ORIGINAL IMMOVABLE PROPERTY DOCUMENTS TO THE LEGAL HEIRS ON DEMISE OF THE BORROWER

The legal heirs of the Borrower should submit the followings to the Branch office of TVS Credit, as mentioned in the Loan Application and the Sanction Letter, where they choose to obtain the original immovable property documents:-

- 1. Request letter by Legal heirs of deceased Borrower and co-Borrower for release of mortgaged original immovable property documents/ moveable property/No Objection Certificate (NOC) or No Due Certificate (NDC) as the case may be
- 2. Death Certificate of Borrower issued by Municipality / Corporation or Registrar of Births / Deaths.
- 3. Legal Heirship certificate of Borrower, issued by Revenue Authorities of Rank not less than Tahsildar/Deputy Tahsildar or Succession Certificate issued by the competent Court.
- 4. Identification Proof of claimants (i.e., legal heirs of Borrower), as per the KYC policy of the Company.
- 5. In case of the release of original immovable property document/moveable property/NOC/NDC, to any one of the legal heirs, then all the other Legal Heirs may jointly submit their request or issue letter of Authority in favour of one or more legal heirs of Borrower to the Company as per the format (Annexure 1).
- 6. Affidavit cum Indemnity Letter as per the format (Annexure 2)
- 7. Property acknowledgment/Receipt by the legal heirs/claimant should be executed upon the receipt of original immovable documents/moveable property/NOC/NDC, as the case may be as per the format (Annexure 3.)
